IMPORTANT INFORMATION

GENERAL

Multipad is a multilayered, atraumatic speciality absorptive dressing composed of a thick rayon highly absorbant nonwoven pad and two polypropylene wound contact layers. Both sides are non-adherent and will not disturb granulation tissue or cause trauma to the wound site.

INTENDED USE

Multipad can be used as a primary or secondary dressing over Multidex®, Kalginate®, and Algidex Ag® dressings, as well as other wound fillers. Multipad can be used in place of gauze and tape and/or other non-adherent dressings to support more absorbancy; no wound contamination from fiber linting: less frequent dressing changes: no trauma to wound site on removal; or to save nursing time.

INDICATIONS

Multipad is used for:

- Dermal ulcers
- Diabetic ulcers
- Abdominal wounds
- · Infected wounds
- Superficial wound
- Lacerations, cuts, and abrasions
- Donor sites
- Second degree burns

CONTRAINDICATIONS

- Not used for second degree burns
- Not for use on patients with a known allergy to the pad components (Rayon and Polypropylene)



<u>∕!</u>\warnings

- Observe wound for any erythema beyond dressing edges which may indicate a sensitivity to the dressing, wound infection or exacerbation of an already infected wound.
- A heavily soiled dressing or a dressing showing 'strike though' exudates should be removed and replaced to avoid wound and/ or skin maceration.
- Local wound care cannot overcome the deficits of unrelieved malnutrition, pressure or trauma, or compromised blood flow
- Interventions must be instituted to reduce/ relieve these factors that contribute to impaired wound healing in order to achieve the optimum outcome.

DIRECTIONS FOR USE

APPLICATION

- 1. Peel open package using aseptic technique.
- 2. Position Multipad over wound.
- 3. Secure with tape, roll gauze, or StretchNet™ Tublar Elastic Bandage.

REMOVAL

- 1. To remove Multipad gently lift dressing from wound; clean and redress wound.
- 2. Dispose of soiled dressing as a biohazard according to facility policy.
